## TRIAL SPECIFICS:

- q Building is available from 5:30pm until 9 pm on Friday evening for set up.
- q Doors will open at 6:30am each day.
- q Crating space is limited. Please be conservative. EX Pens allowed for multiple dog crating only.
- q No Outside Food or Drinks except dog treats and MACH cakes. A Café is available on the premises with good selection of food and drinks at reasonable prices.
- q Puppies under 6 months are strictly prohibited
- q All dogs must be on leash at all times except when in the ring or in the designated warm-up areas.
- q Handlers in all classes are permitted to walk the course, without a dog prior to the start of the class. Course familiarization will NOT be offered.
- q Exhibitors are responsible for being at the gate when it is their turn to run.
- q All equipment shall meet the specifications in the current edition of "Regulations for Agility Trials". Electronic Timers will be used.
- q A warm-up area consisting of a regulation agility jump shall be provided for all exhibitors.
- q Exhibitors are responsible for double-checking the accuracy of their entry form.
- q Armbands will **not be mailed**. These will be in a book near the Ribbon table.

## CONFIRMATION:

- q **A Preliminary confirmation will be sent to the e-mail address on the AKC entry form after your entry has been processed. Please review the information for input errors and notify the Trial Secretary of any corrections immediately.**
- q **Final confirmation of entry and schedule of judging will be sent to the email address on the AKC Entry Form after the closing date. Anyone requesting a mailed copy MUST include a self addressed stamped envelope with their entry.**

**ENTRY FEE** \$24.00 for the first entry of a dog; \$13.00 for second entry and \$13 for third entry of the same dog per day. (Includes a per day per dog \$3.00 AKC recording fee) Envelopes/transactions cannot have entries for more than the (10) dog maximum.

***No hand deliveries for the first 24 hours.***

**REFUNDS** Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by the action of the Show Committee.

Bitches in season are not permitted to compete in Agility Trials. Refunds will be given (less AKC fees) for bitches in season or dogs injured after closing. Written notification, including a **Veterinarian's letter**, must be received by the Trial Secretary no later than **6PM Wednesday, June 10, 2009**.

Entry fee will not be refunded if the trial cannot open or be completed by reason of civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. The club may cancel the trial in extreme weather conditions.
